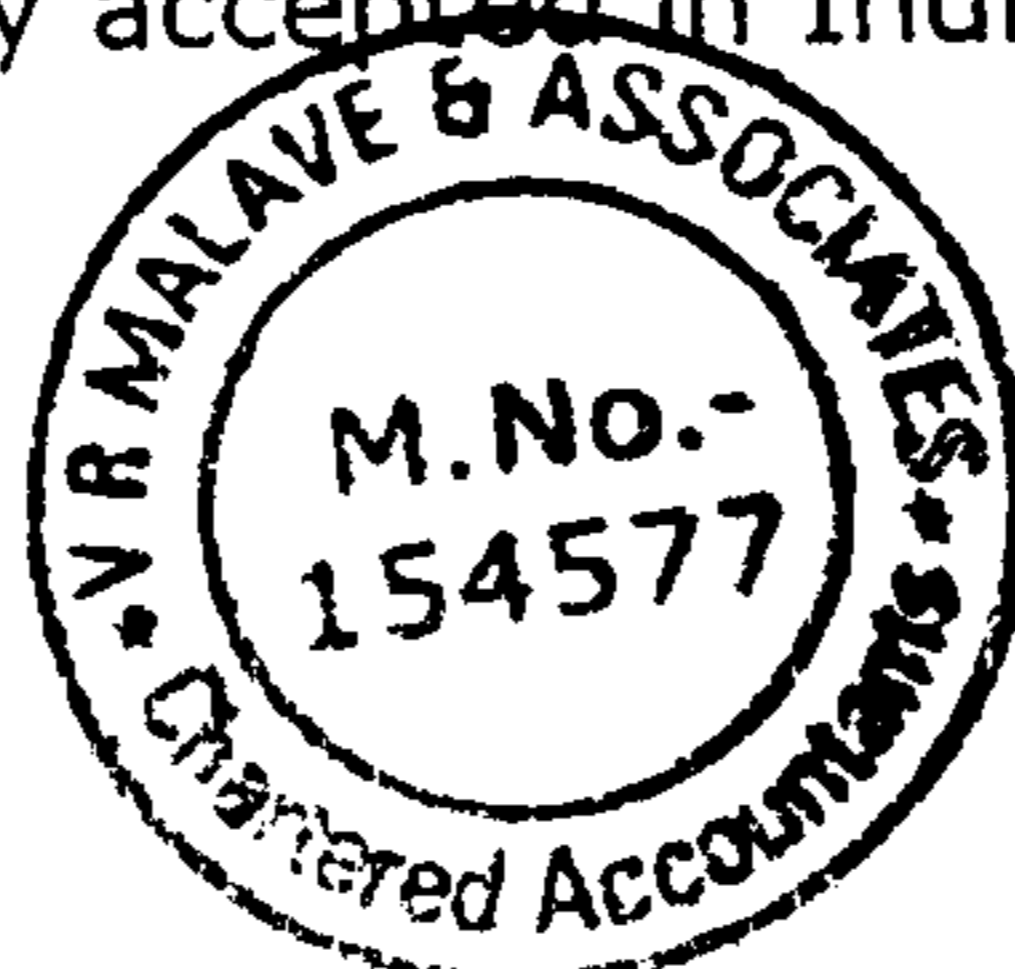
Further, we report that:

(iv) In our opinion and to the best of our information and according to the explanations given to us, the said accounts give a true and fair view in conformity with the accounting principles generally accepted in India:

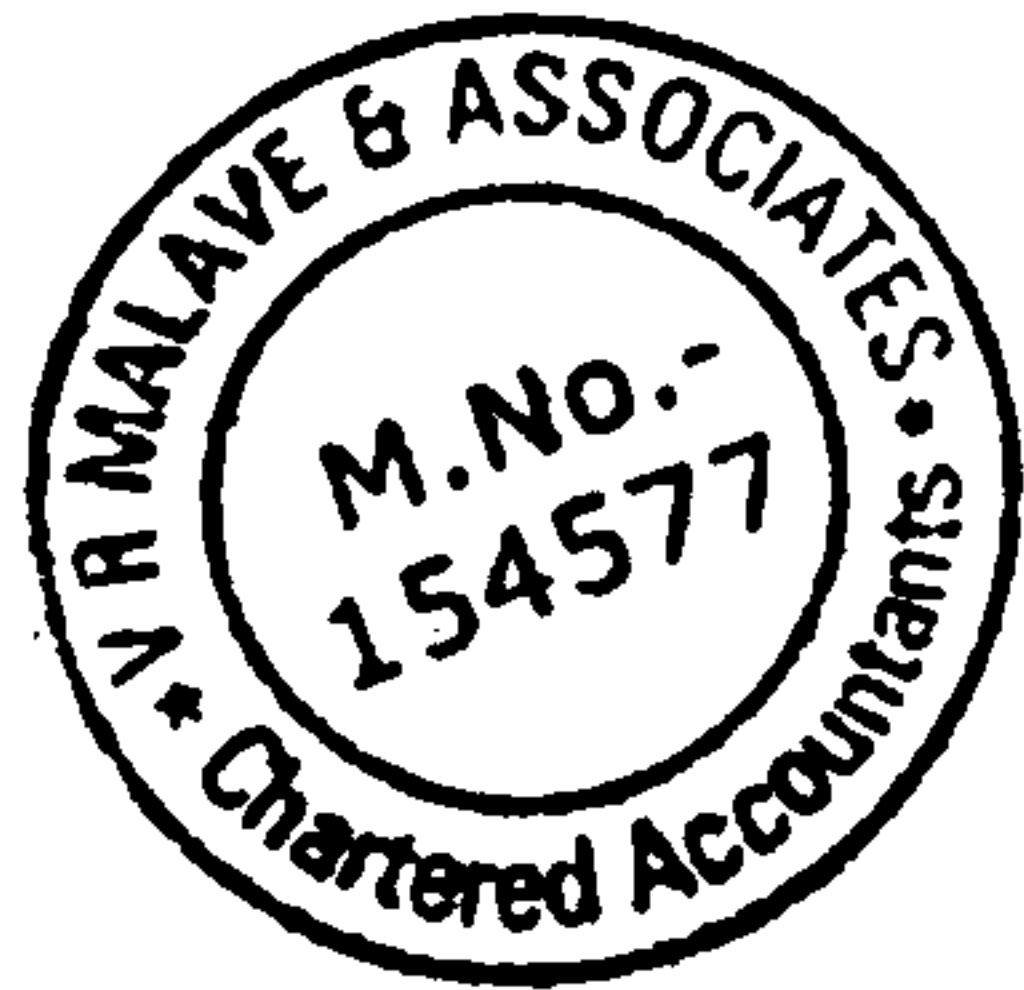

**SIGNIFICANT ACCOUNTING POLICIES AND NOTES ON ACCOUNTS:-**

1. Basis of Preparation:

The financial statements have been prepared to comply in all material respect with the Accounting Standard and Guidance Note issued by the Institute of Chartered Accountants of India. The financial statements have been prepared under the historical cost convention. The basis of recognition of expenses has been on accrual basis whereas revenue has been recognized on receipt basis during the year of audit.

2. Use of Estimates:

The preparation of financial statement in conformity with generally accepted accounting principles requires management to make estimates and assumption that affect the reported amounts of assets and liabilities and disclosure of contingent liabilities at the date of the financial statements. Although these estimates are based upon management's best knowledge of current events and actions, actual result could differ from these estimates.

3. Fixed Assets:

Fixed Assets are stated at cost of acquisition. Cost of acquisition of fixed assets is inclusive of Freight, Duties & Taxes. No fixed assets held by party during the audit period.

4. Depreciation / Amortization:

No depreciation is provided on fixed asset. As no fixed assets available to balancesheet.

5. Employee Benefits:

Remuneration and other employee benefits payable are accounted for on cash basis.

6. Revenue Recognition:

The basis of recognition of expenses has been on accrual basis whereas revenue has been recognized on receipt basis during the year of audit. During audit period party has not provided any financial assistance to its candidates for their election expenses.

7. Provisions:

A provision is recognized when the party has a present obligation as a result of past event; it is probable that an outflow of resources will be required to settle the obligation, in respect of which a reliable estimate can be made. Provisions are not discounted to its present value and are determined based on best estimate required to settle the obligation at the balance sheet date. These are reviewed at each balance sheet date are adjusted to reflect the current best estimations.



**8. Cash Flow Statement:**

Cash flow statement is prepared as per Indirect method as referred to in AS-3 "Cash Flow Statement".


