Opinion

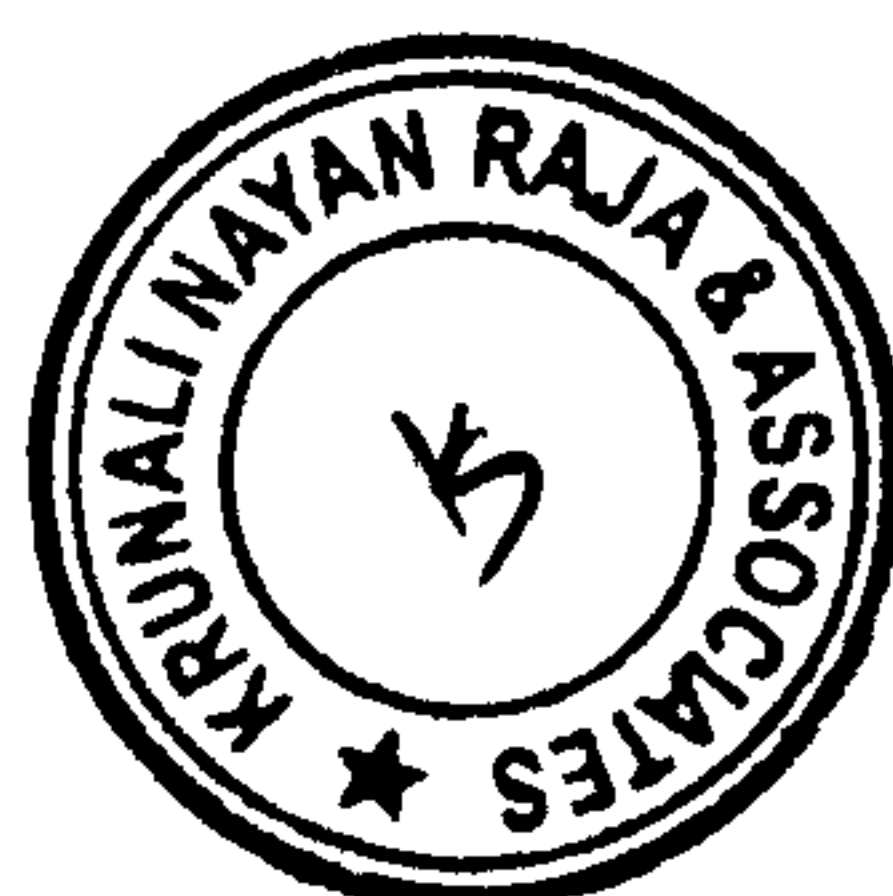
