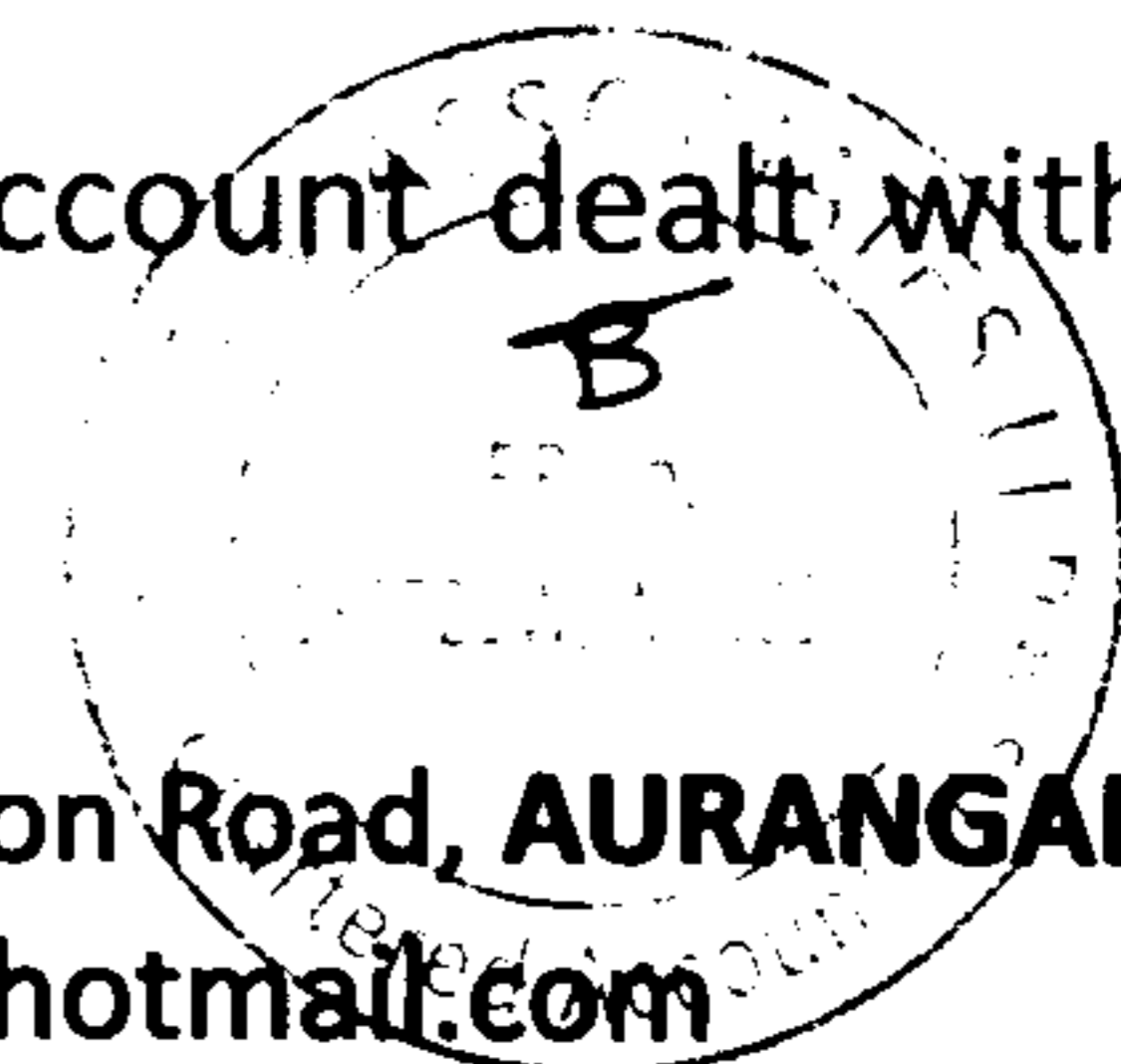


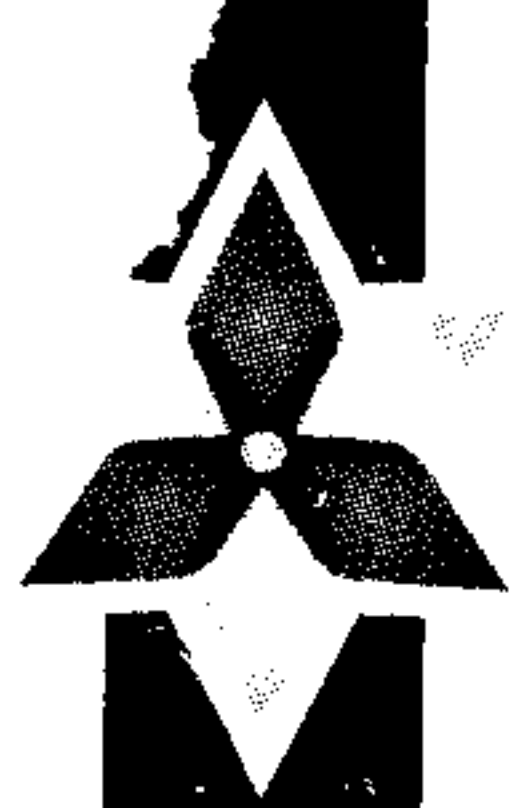
AUDITOR'S REPORT

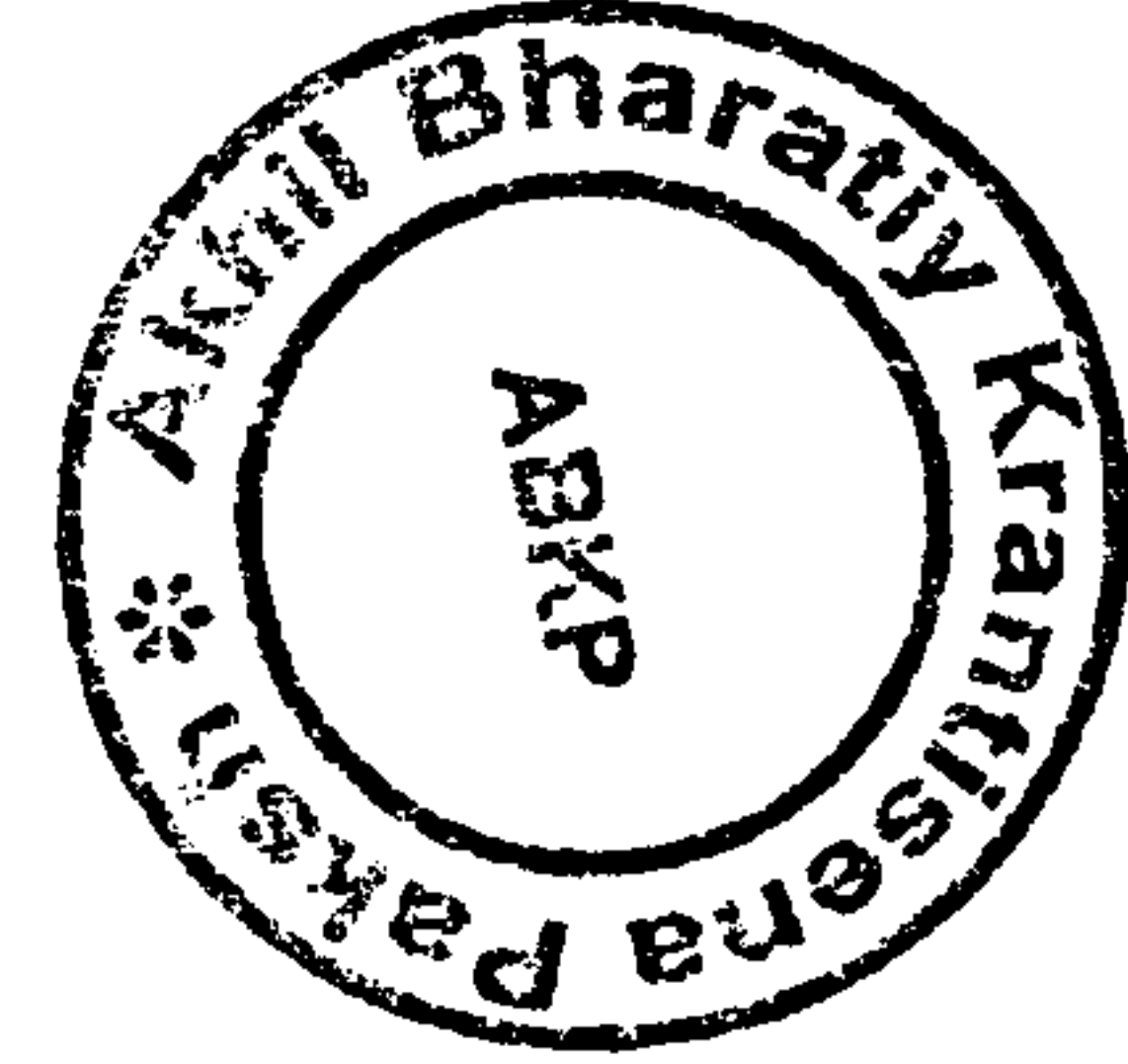

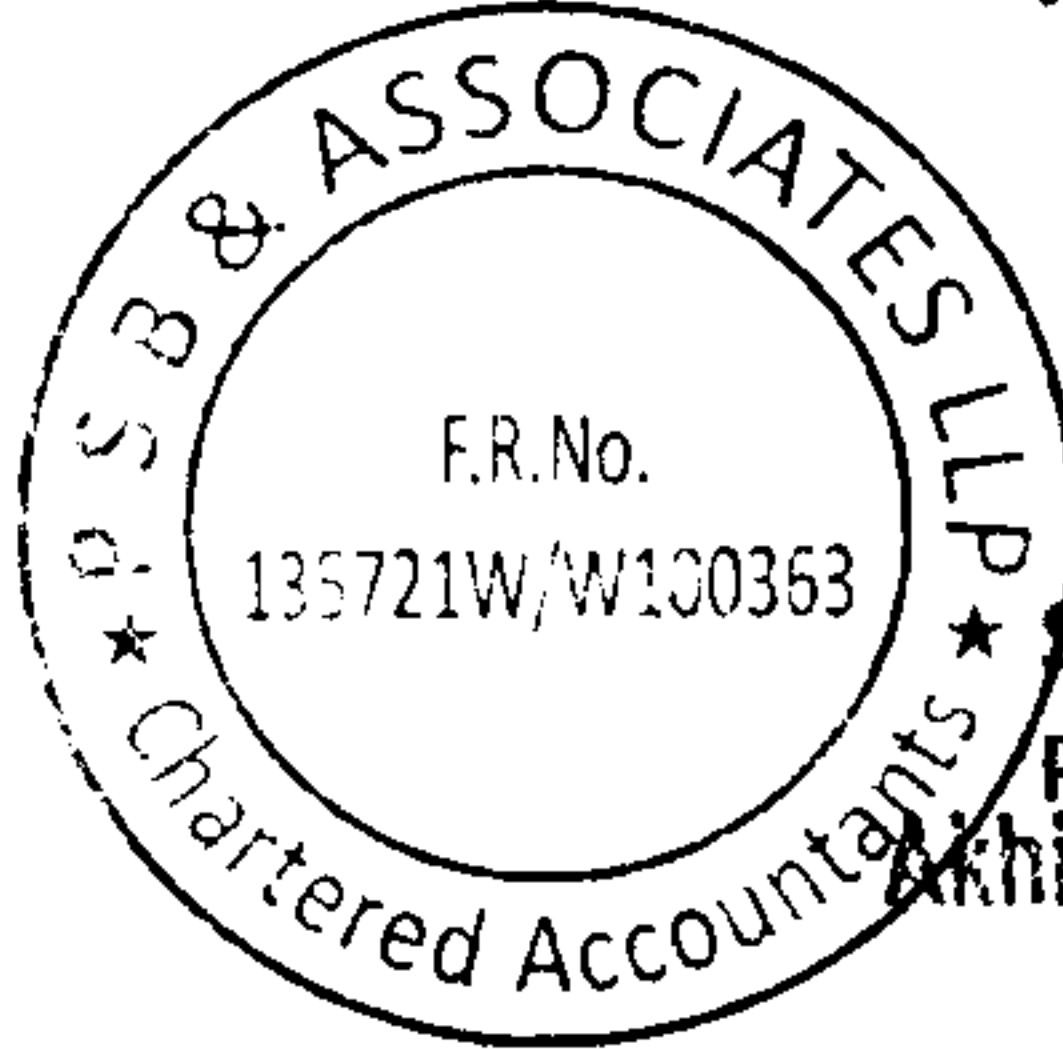

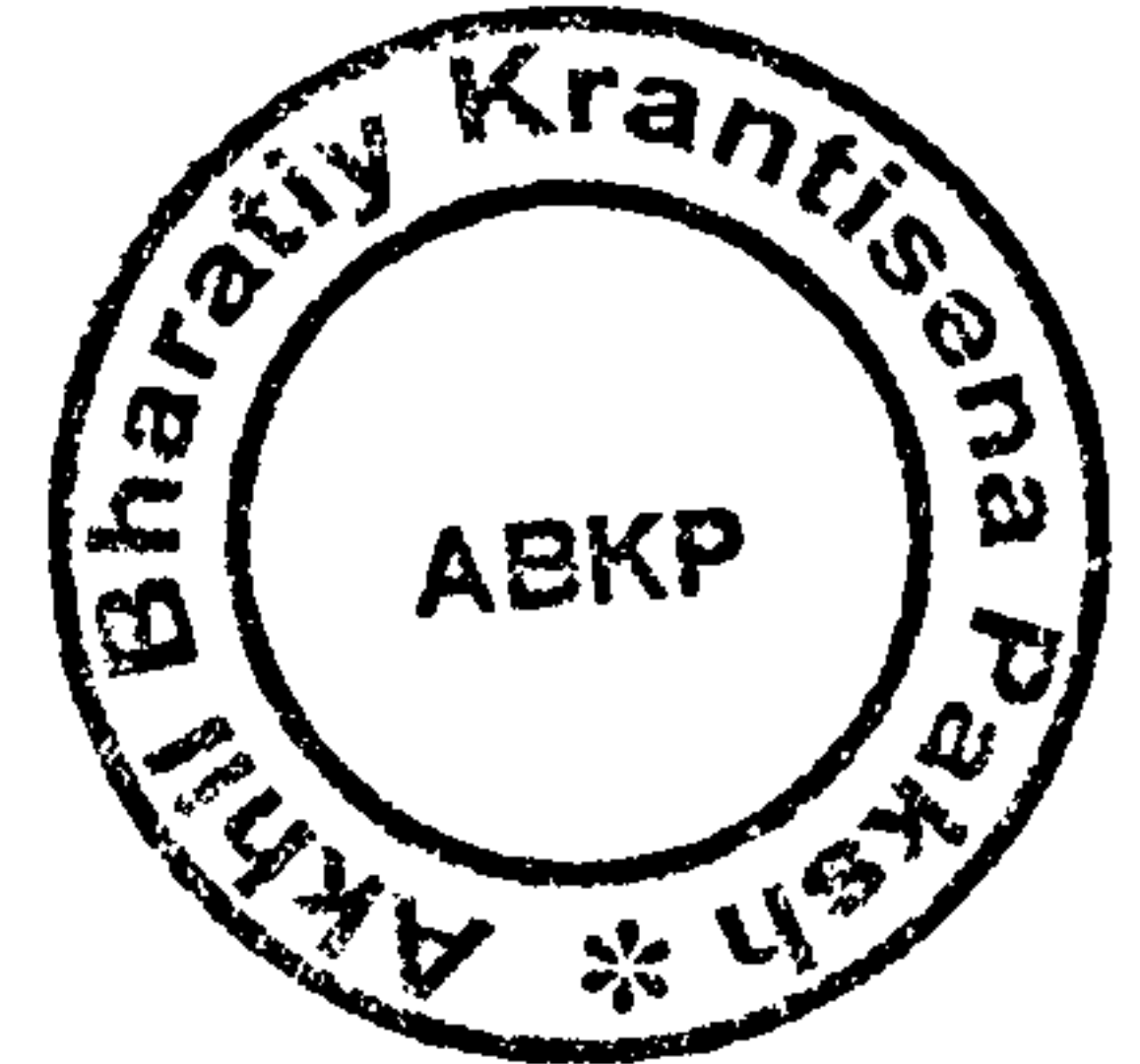
