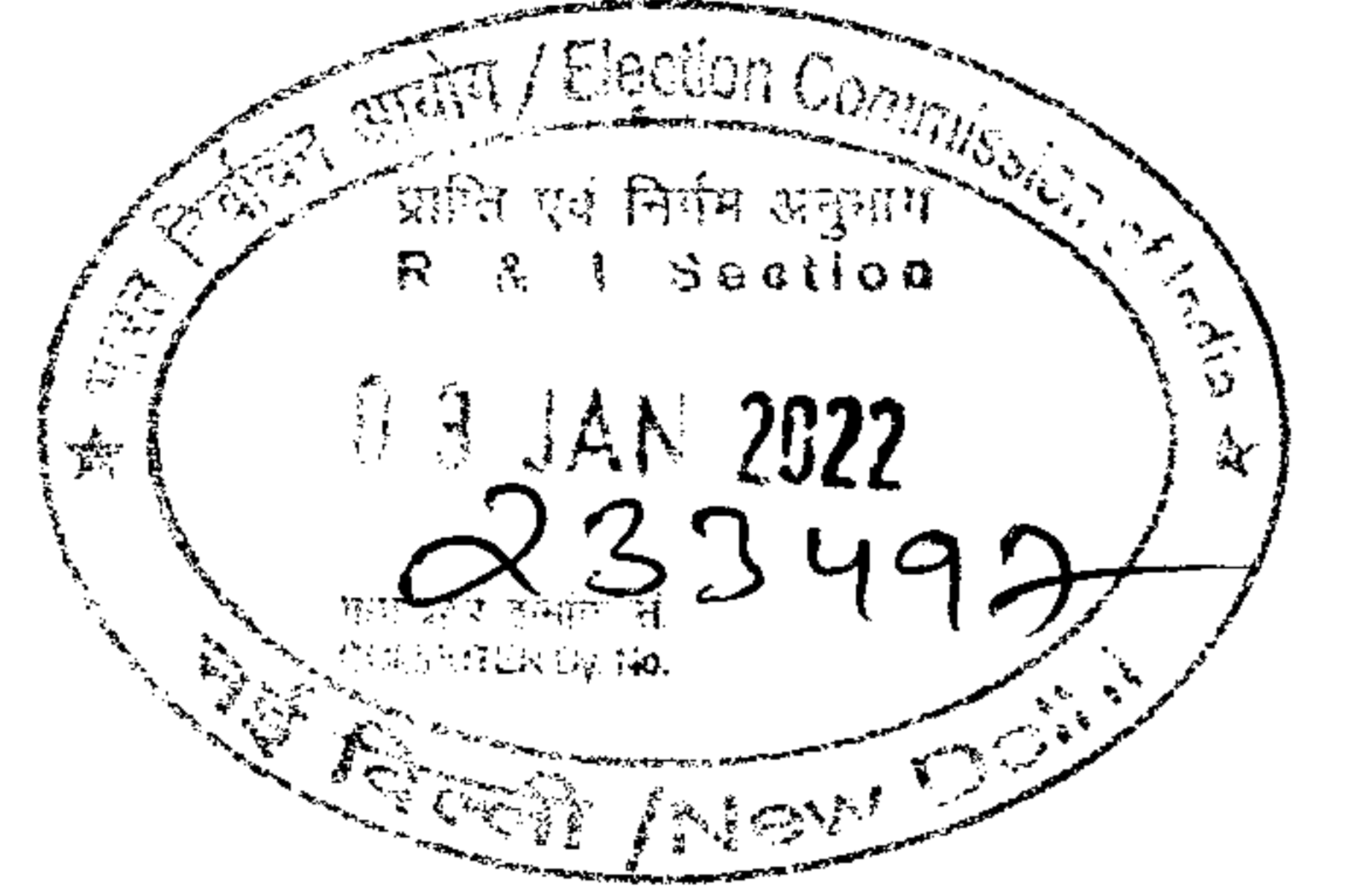

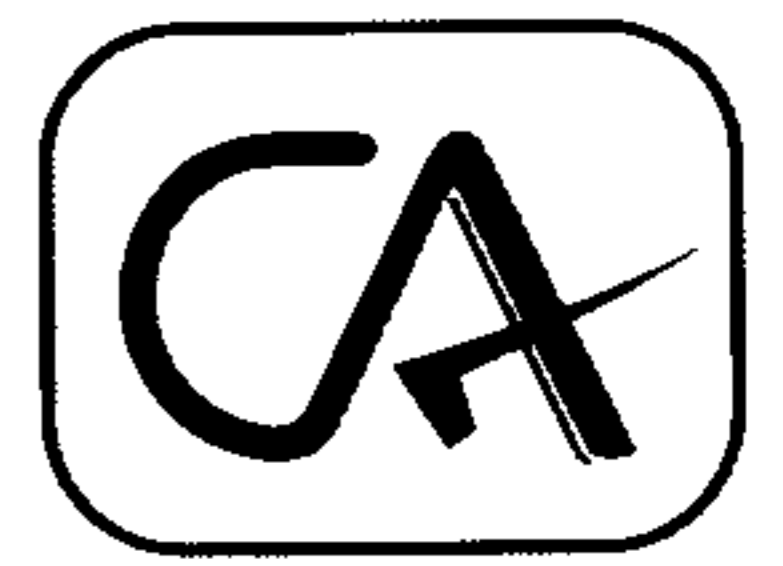

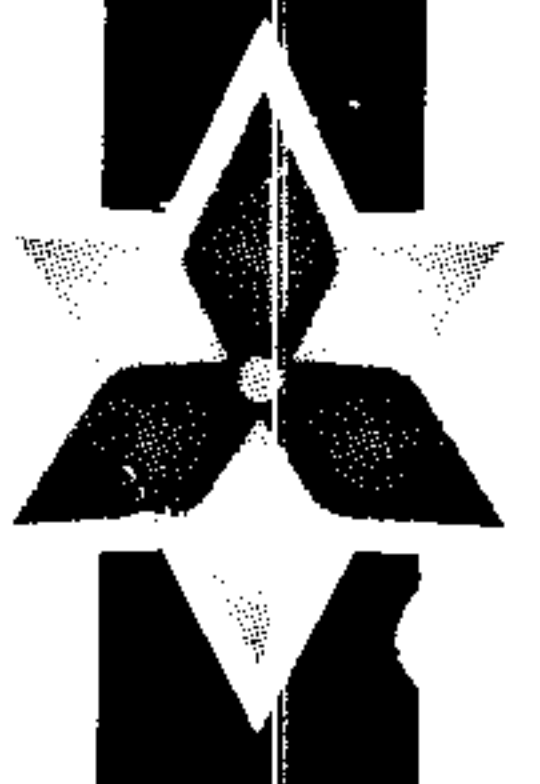
AUDITOR'S REPORT

Subject to the notes on accounts as per Schedule "A" forming part of the Balance sheet and Income & Expenditure Account we report as under: -

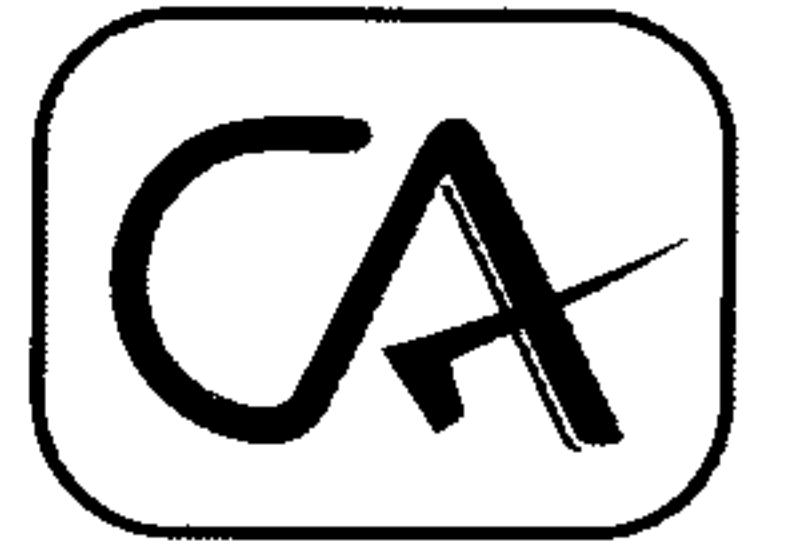
1. We have sought and obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purposes of our audit.


