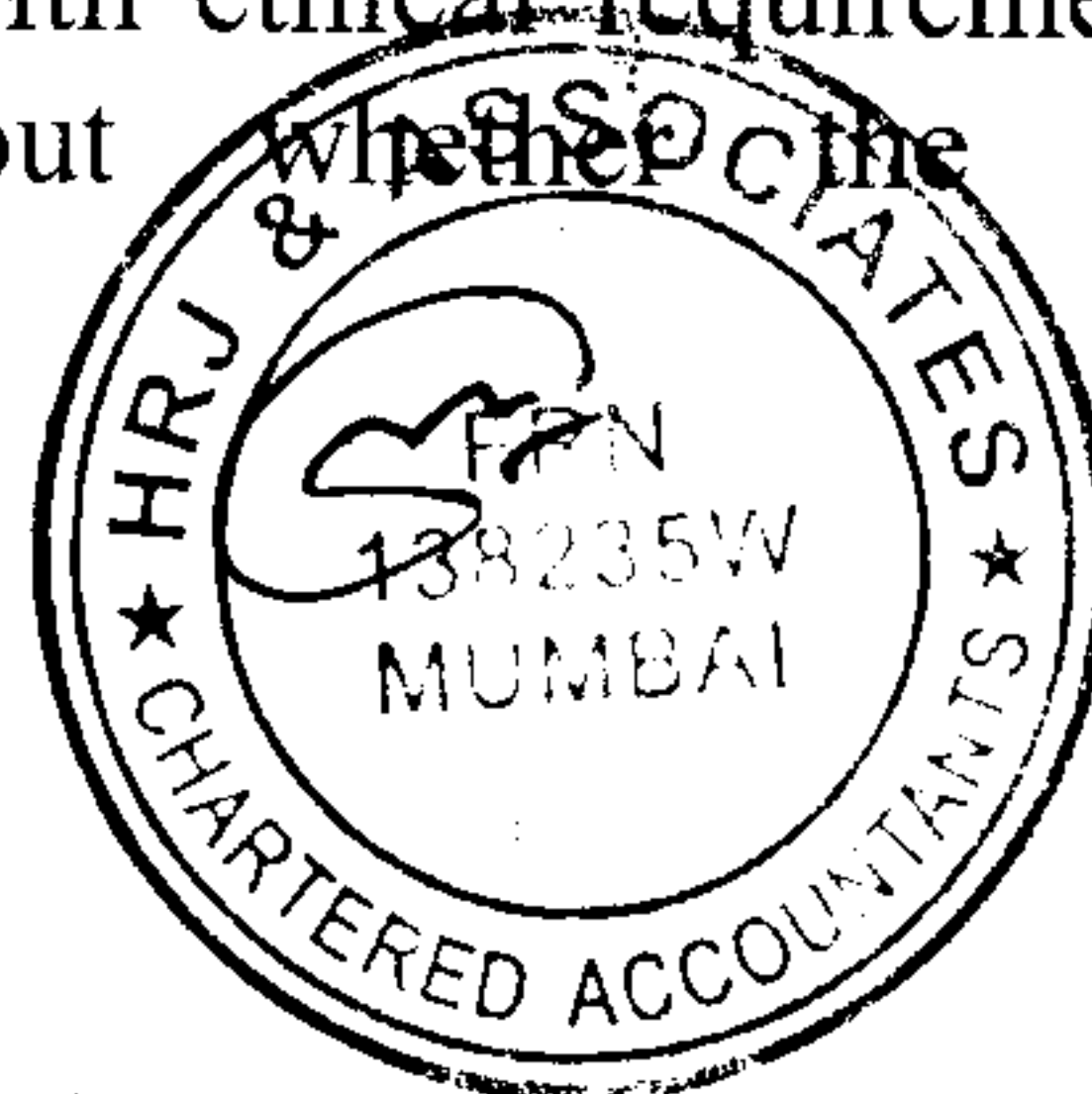
### **Management's responsibility for the Financial Statements**

In preparing the financial statements, management is responsible for assessing the ability of Rashtriya Swarajya Sena (the Party) to continue as a going concern, disclosing, all applicable matters related to going concern and using the going concern basis of accounting unless the management intends either to liquidate the Party or cease the operations. Those charged with governance are responsible for overseeing the Party's financial reporting process.
