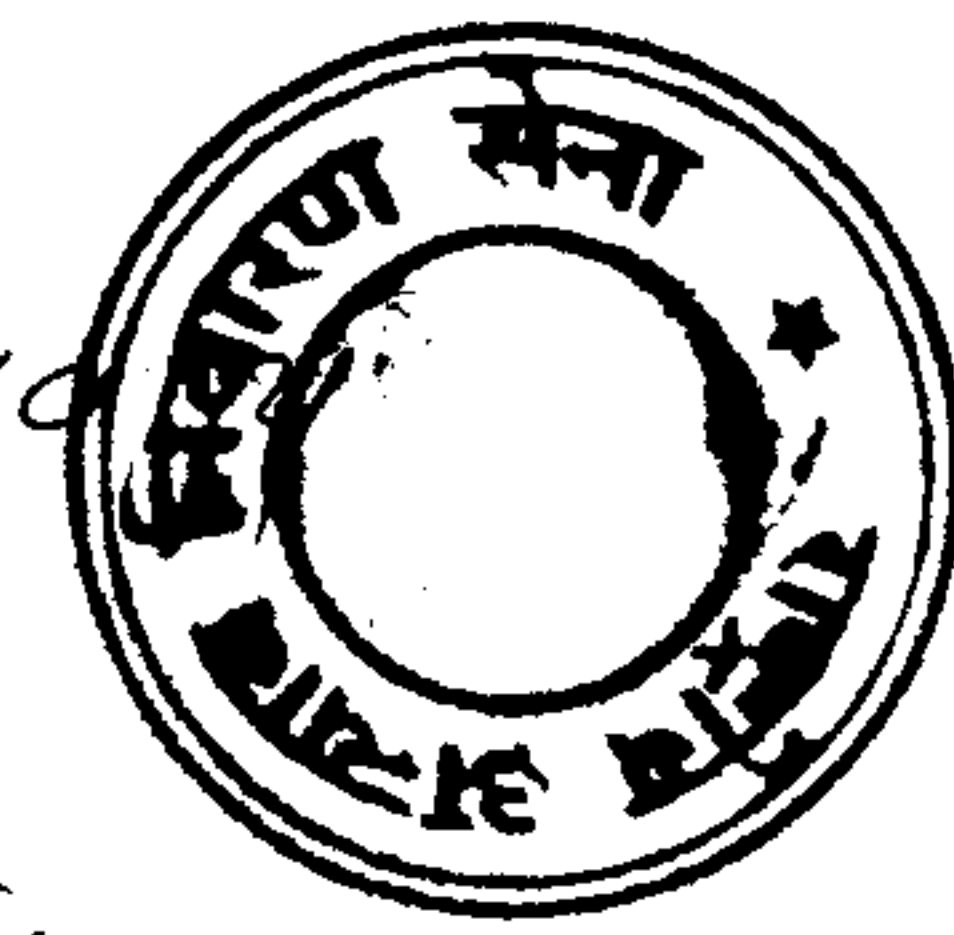

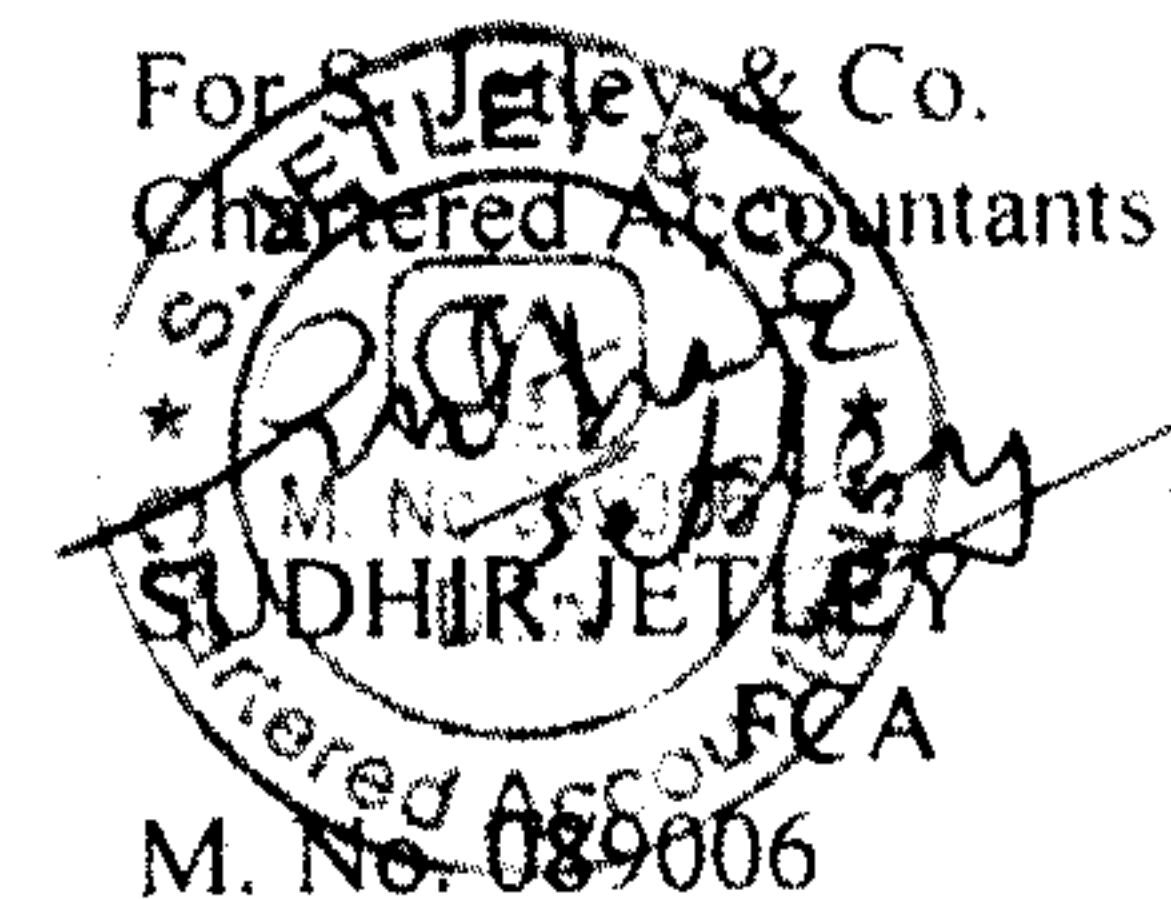
We report as under :-
