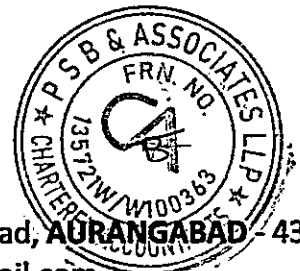


AUDITOR'S REPORT

3. The Balance Sheet and Income & Expenditure account dealt with by this Report agree with the books of account.



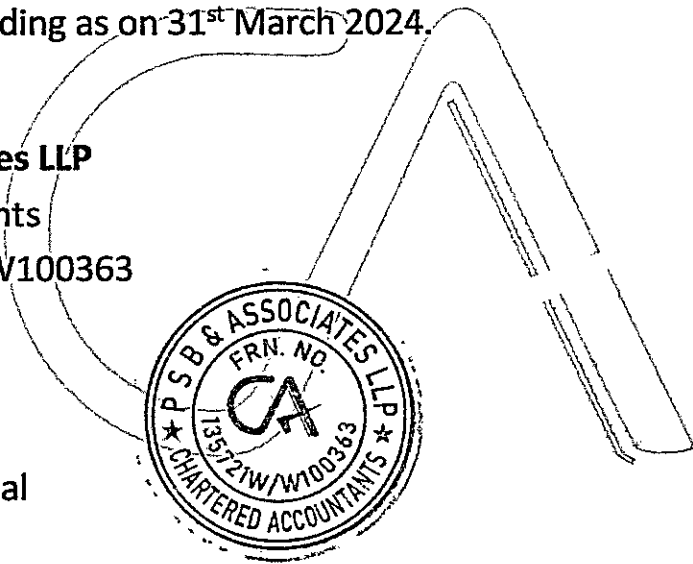

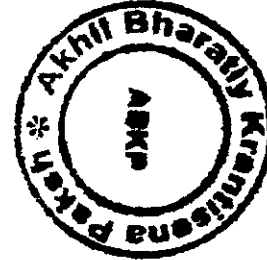
