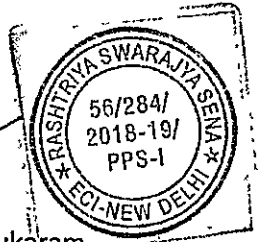

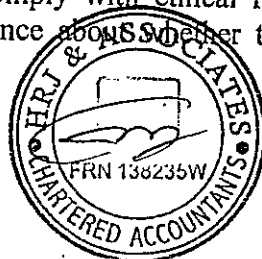
Management's responsibility for the Financial Statements

Opinion

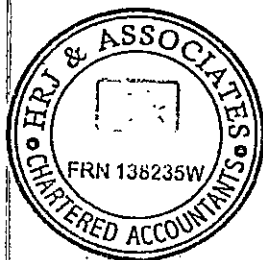


Report on Other Legal and Regulatory Requirements
