



AUDITOR'S REPORT

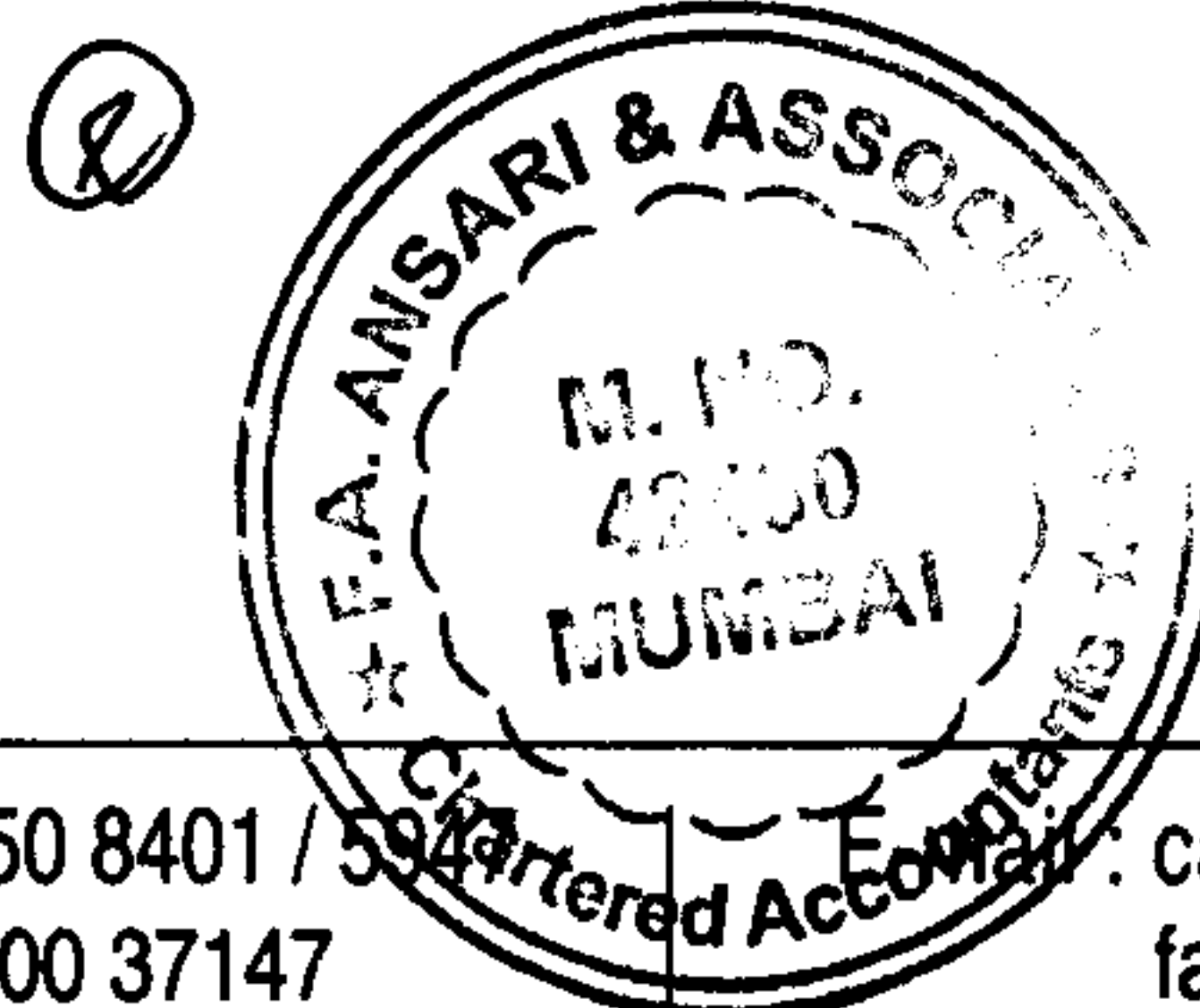
