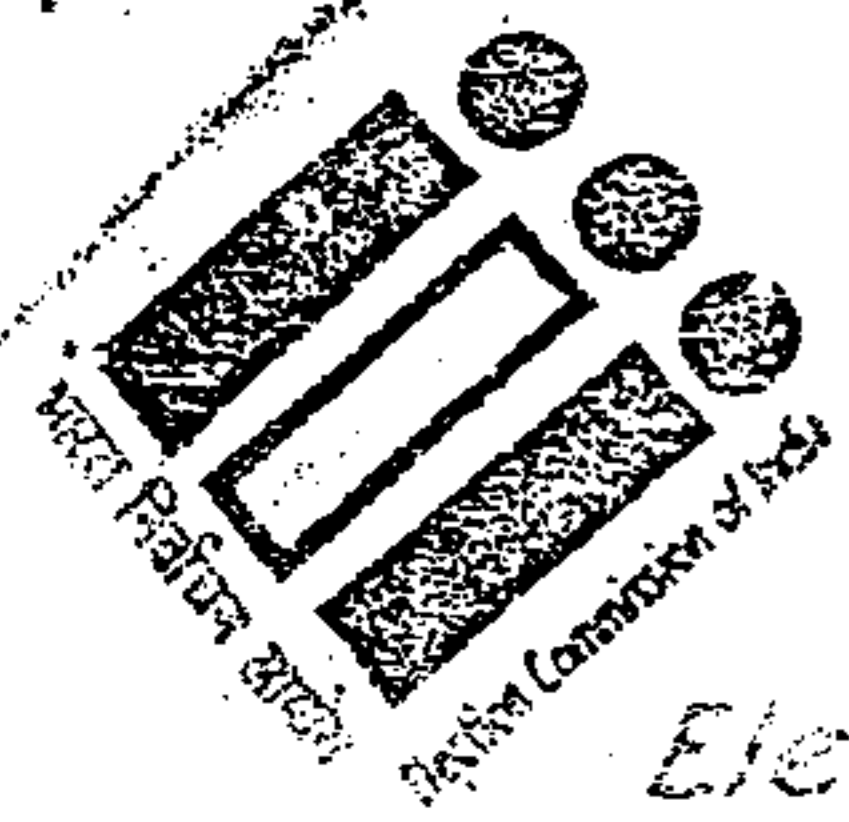


3. It may be noted that the registration will not entitle the party to the reservation of any exclusive symbol for it. However, the candidates duly set up by the party at an election will be entitled to benefits of preference in allotment of free symbols over independent candidates under paragraph 12 of the Election Symbols (Reservation & Allotment) Order, 1968.

4. As per the provisions of Section 29B and 29C of the Representation of the People Act, 1951 (dealing with contribution to political parties) the party is required to submit to the Commission, a report of contribution received in excess of Rs. 20,000/- in a financial year, in the format in Form 24A appended to the Conduct of Election Rules, 1961. In such report, the party has to mention the Permanent Account Number (PAN) of the party. Therefore, you are advised to obtain Permanent Account Number (PAN) in respect of the party and inform the details of the same to the Commission within six months of the registration.

5. The Registration No. of your party is 56/155/2009/PPS-I.

6. It is also informed that the Commission is not concerned with the flag of political parties.

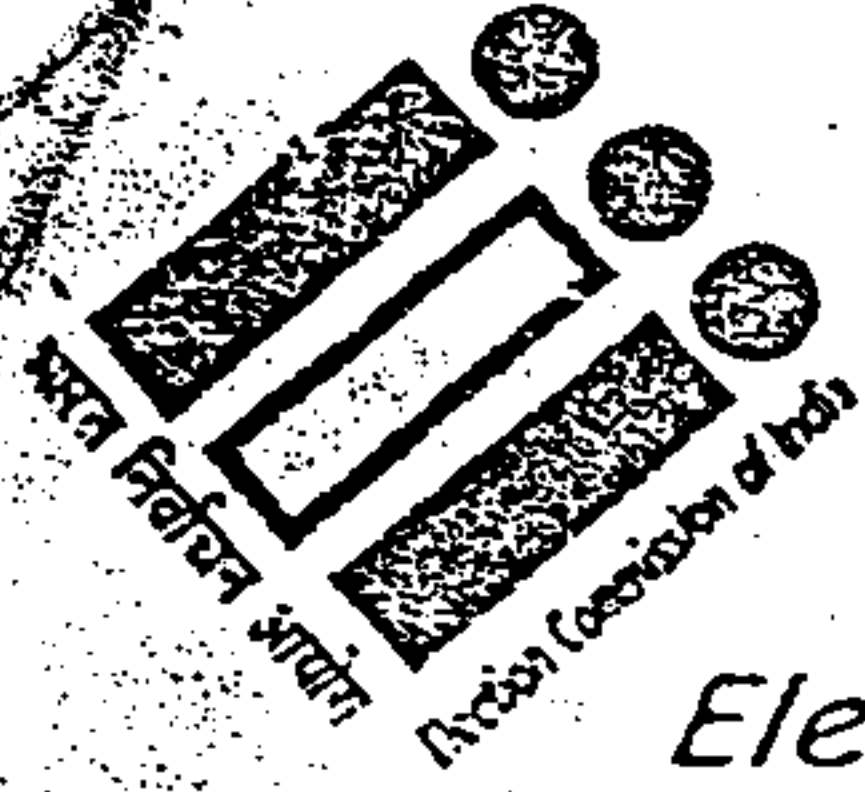

महोदय,

मुझे, यह कहने का निदेश हुआ है कि भारत निर्वाचन आयोग ने “ राष्ट्रीय किसान कांग्रेस पार्टी ” का राजनैतिक दल के रूप में रजिस्ट्रीकरण करने के लिए आपके तारीख 25.05.2009 के आवेदन और उक्त आवेदन-पत्र में विवरण/प्रकथन के समर्थन में प्रस्तुत कागजातों और दल के प्रतिनिधि/प्रतिनिधियों द्वारा उक्त आवेदन के सम्बन्ध में तारीख 07.12.2011 को आयोग के समक्ष दी गई प्रस्तुतियों पर विचार करने के बाद लोक प्रतिनिधित्व अधिनियम, 1951 की धारा 29क के अधीन “ राष्ट्रीय किसान कांग्रेस पार्टी ” का तारीख 27.04.2012 से राजनैतिक दल के रूप में रजिस्ट्रीकरण कर लिया है ।

2. लोक प्रतिनिधित्व अधिनियम, 1951 की धारा 29क की उपधारा (9) में यथा उपबंधित दल अपने नाम, मुख्यालय, पदाधिकारी, पते या अन्य किसी तात्विक मामले में, यदि कोई हो तो, किसी प्रकार के परिवर्तन की सूचना आयोग को शीघ्र देगा । इस प्रकार के परिवर्तन की सूचना निम्नलिखित दस्तावेजों के साथ भेजी जाएगी:-

- (i) दल के संविधान में निर्धारित सक्षम समिति द्वारा पारित किए गए संकल्प तथा उस बैठक का सम्पूर्ण कार्यवृत्त जिसमें ऐसे परिवर्तन/संशोधन का निर्णय लिया गया है, कि एक प्रमाणित प्रति ।
- (ii) उपरोक्त बैठक में उपस्थित पदाधिकारियों के नाम की सूची ।
- (iii) उपरोक्त बैठक में उपस्थिति रजिस्टर का उद्धरण (extract) जिसमें भाग लेने वाले सदस्यों के हस्ताक्षर हों, की एक प्रमाणित प्रति ।


3. यह भी नोट किया जाए कि रजिस्ट्रेशन के कारण दल अपने लिए किसी अनन्य प्रतीक का हकदार नहीं होगा तथापि निर्वाचन प्रतीक (आरक्षण और आबंटन) आदेश, 1968 के पैरा 12 के अधीन पार्टी द्वारा सम्यक् रूप से खड़े किए गए उम्मीदवार को मुक्त निर्वाचन प्रतीक के आबंटन में निर्दलीय उम्मीदवारों के ऊपर वरीयता का लाभ दिया जायेगा ।

4. लोक प्रतिनिधित्व अधिनियम, 1951 की धारा 29ख और 29ग के प्रावधानों के अंतर्गत (राजनीतिक दलों को अंशदान से संबंधित), दल को एक वित्तीय वर्ष में रू० 20,000/- से अधिक प्राप्त अंशदान/अंशदान के बारे में निर्वाचनों का संचालन नियम 1961 में संलग्न प्रारूप 24क में एक रिपोर्ट आयोग में प्रस्तुत करना आवश्यक है। ऐसी रिपोर्ट में दल की स्थायी खाता संख्या (PAN) का विवरण देना होता है। अतः आपको यह सलाह दी जाती है कि आप अपने दल का स्थायी खाता संख्या (PAN) प्राप्त कर आयोग को उसका विवरण दल के पंजीकरण से छः माह के भीतर सूचित कर दें।
